- A. Call to order 7:30PM: Additions to the Agenda: None
- B. Adoption of the minutes from QCB meeting: February held Mar 7th, 2012 MSC: YES
- **C. Train Report**: Brian: CTA has issued a ruling that covers several points: 1. this complaint, in their opinion, is a community based complaint. And, they feel the Federal Court of Appeals agrees as personal names were never mentioned in the CFA ruling. 2. Matthew Laird requested release from this matter, and as no one has objected they have released him at no cost, and further, no costs have been awarded to the rail companies. 3. The City is a party to this agreement and as such their input and comments will be considered in this decision. 4. The CTA will honour the request of the rail companies to not have the settlement agreement made a part of the public record. 5. The CTA has ruled that the agreement is final and it can be made an order of the CTA and enforced by the CTA. 6. There are 30 days in which the rail companies, city of New Westminster and QCB may appeal this decision. We intend to put a copy of the decision on the QCB website depending on content.

- **E. President's Report:** Penny: New Email has been set up presidentqcb@gmail.com for correspondence as the current email is still not working properly. Attended the Pattullo Bridge replacement meeting and felt the information was not forth coming. Not presented with a four lane option and encourage all members to attend as this will affect our three ways in and out of Quayside.

- G. Regular Business:
- **1. Westminster Pier Park:** Opening soon no formal date set. Issues surround the use of the black area of the old pier and weight restrictions. Access is an issue for now only one way in that is via Larco property. Looks great waiting for further information from the city regarding cost and opening date.
- **2. Civic (Convention) Centre**: Mike (City Rep): No in attendance. Hole looks very deep and water is coming in from the walls of the hole. Developer for the office tower has pulled out of the project and the city is looking for a new partner in the building.

- 1. Quayside Boardwalk Festival and Sale 2012: James: Table requests are coming in.
- **2. Fraser Feast 2012:** Looking into a July 21st festival since Fraser Festival has been moved to Sept. QCB has expressed an interest in support this event since there is only one other event in the summers.
- **3. Traffic, Buses, Boardwalk & Gateway Committee:** Michail: Councilor McEvoy is the new chair. Pattullo was discussed re tolls and lanes. Discussion around schools, traffic volume, hills, # of lanes, no bridge at all, ect.. more input from the public requested. Talked about Carnarvan & McInnis overpass. Overpass is in terrible condition. Need for speed signs, flashing pedestrian lights ect.

- **4. Community Policing:** Gavin: March 15th, 2012 Meeting; Deputy Chief L. Stenerson reported that the City is in good shape, relatively speaking crime-wise. Downtown New Westminster is going through a time of rapid growth and property crime is dropping in the area. Theft from auto is still a problem and is always a topic of conversation. One area that might see a jump in some way could be the Market, in that with more cars in the parking lot, more thefts could occur. Additionally, it should be noted that with the better weather upon us, there will be more activity with relation to "Boardwalk Drinkers", IE illegal drinking outside on the Boardwalk. The Westminster Quay is in relatively good shape and is again not on the radar of the police. What is notable is that the police want to bridge communication with the citizenry. The police will be launching a new, more interactive web-site in the near future. Officially, "No Call Too Small" is policy.
