A. Call to order 7:30PM: Additions to the Agenda: Letter from Dorothy note below

B. Adoption of the minutes from QCB AGM meeting: Sept 28th, 2011 MSC: YES

C. Train Report: Brian: The matter is now back before the CTA. The CTA is directed by the Federal Court of Appeals to decide if the Settlement Agreement was final. The CTA asked the Rail companies for their response on Oct 20th and provided them 10 days to reply. We are currently awaiting the response from the rail companies. We expect the rail companies to say it was final. In past correspondence the CTA has indicated that an agreement has to be filed with the CTA to be final. Will forward the board any correspondence received from the CTA.

- **4. River Market**: James: Waiting until after Nov 19th to set up a tour. New stores are opening in a couple of weeks. Members are encouraged to take in the recent additions and stop by & look at shops

H. Committee Reports and Appointments:

- 1. Quayside Festival and Sale: James: We attended the fundraiser the total contribution was \$1,220.00 Two people paid for their tickets to help the Royal City Musical Society and a check was presented to the Executive Director. - **6. Off Leash Dogs:** Ted: It looks as if there were no patrols done along the Quay for the month of September; I need to speak to my staff and find out why. As for the other issues that were discussed in our walk-about, here is what I have done to address these issues; A. Plastic Bag Dispensers I have requested that the one at the Submarine Park be replaced as it is rusting and does not look very nice. I have asked to have a dispenser mounted near the entrance of Reliance Crt. and K de K Crt. B. Sand and Wood Chips in the Submarine Park Playground maintenance staff will look and the current depth of both and refresh as required. C. Lighting in the Submarine Park This matter was previously discussed and it is felt that lighting this area would in fact serve to encourage instead of discourage youth to congregate in the park after dark. There is also cost considerations; this park in intended for younger children and by lighting this park it would probably not make a difference to after dark usage, so the cost of installing and maintaining lighting would not be justified. D. Fencing off a section of the park This matter was forwarded to Parks staff for consideration.

I will have a flyer out to info@QCB at the beginning of November for distribution to the QCB board members for posting on the bulletin boards so that residents have a month notice of the contest. Anchor Pointe: NTR. Dockside: NIA Excelsior: Evaluation report is almost complete. Laguna Landing: NTR. Lido: some problems with people parking in loading zones and fire lanes, there is nothing to report. QuayWest: NTR. Quayside Terrace: Coop reconstruction taking place and car broken into. Rialto: Repainted elevators. Promenade: Boilers to be replaced & should reduce gas cost 15-20%/yr. Riverbend: NTR. Riviera: will start to replace elevators in January '12. Tiffany Shores: wall is finished to boardwalk – 9 decks to finish. Tower I: still trying to get windows replaced – elevator to be started in Jan '12. Tower II: NTR. Murano: NTR. Westport: AGM takes place next week. Westminster Landing: struggling with Canada Post to deliver mail during renovations, will not deliver to each door and have to pick up at post office. Renovations will finish in 2012. The Q: expansion joints causing problems.

QUAYSIDE COMMUNITY BOARD (QCB) is comprised of one delegate and one alternate from <u>(correction 18 strata councils)</u> seventeen of seventeen residential buildings in the geographical location known as 'The Quayside' in New Westminster, BC, Canada. This group of dedicated members represents just under 2000 units <u>(correction 2230 units)</u> and an estimated 4500 plus individual residents in this close-knit community. (QCB website)

If work that the QCB does is useful and meaningful then residents should be kept informed in a timely fashion re work that the Board does, and most importantly, what issues and decisions are discussed at each meeting. At present, with long delays re circulating the minutes to strata's or posting on the website, this is not the case and the work of the Board has very little relevance.

Any Quayside resident wishing to be aware of, or involved in, Quayside Board issues is soon frustrated in trying to find information about current Board issues and decisions. The website is seldom updated. The last minutes posted are May 25, 2011. Most Board members only received e-mail copies of the June meeting just prior to the September one.

The QCB website informs the reader that: "The minutes are posted on this site only after they have been approved at the following meeting of the **Board.** Posting of minutes will be delayed approximately one month from date taken." Is this done?

Board members and residents in member complexes." To rely solely on individual strata representatives to interpret meeting discussion and keep the strata's informed about the Board assumes too much. Some of the representatives are not on the strata councils, some are new to the Board and the issues discussed, and some are not even at the meeting. The minutes remain an important document and play a vital role in ensuring that all strata's and members of the community are provided, in a timely manner, with as complete information as possible re Quayside issues.

Ed Mina, in Mina's Guide to Minute Taking, notes:

- Minutes of meetings are important documents, for recording consensus and decision-making and for tracking the evolution of issues and the history of an organization. *P.9*
- they serve to remind individuals who attended a meeting, and those who missed it, of decisions made and follow-up commitments. *P* 12
- If draft minutes are circulated shortly after the meeting, members will be more likely to remember what took place, and better able to help in creating accurate minutes. Members will also be reminded in a timely manner of any follow up duties they agreed to perform. p77

The letter and intention were discussed and a conclusion reached that it would be great if we could speed up approval of the minutes in order to get them to the membership faster. It was noted that this is a volunteer board and the secretary role was the most difficult to fill. It was suggested sometime ago to pay someone to do this role, however a volunteer came forward. Currently this is done when time permits. Suggestions were presented on email approval and placement on website as soon as possible. It was also discussed that important items are distributed as soon as possible. There was a general consensus that the board's work is relevant and the most important aspect are the strata reports which speak to the very issue of relevance to strata councils and advice offered at this level. One example is that it provided a means and connection for the lagoon issue to be restarted when members connected after one of the board meetings. Various examples of the connection between strata councils on issues like fireplace repairs, windows, management companies to name a few along with many other important facts. These are brought back to individual strata councils for review, discussion and in some cases a saving of time and money. It was resolved to try and do better as far as communication is concerned but recognized that this is a volunteer resident association. Further that some conversations between strata members is reviewed by individual councils and not necessarily for all members of the Quayside Board. This allows for generous discussions between members and less formal exchange of information that benefits the community as a whole.

- 2) Mike requesting a poster on bed bugs it was discussed and left to individual strata's to deal with.
- 3) Various debates for the election were discussed and sent to members for posting
- 4) Strata Advocate results of survey available at www.strataadvocate.ca look for link and meeting Nov 5 sent to members earlier in the month.
